

**ADVANTAGE ROOFING'S "SHELTER A HERO" ROOF GIVEAWAY**  
**TERMS AND CONDITIONS OF ENTRY**

In order to show their gratitude for the sacrifice of those who serve our country, Advantage Roofing is offering a free roof replacement to one area veteran in need of a new roof. The following rules and regulations apply:

1. **How to enter.** There is no purchase necessary for entry. Eligible entrants may submit an Application by visiting the Advantage Roofing website at [www.gorooft.com/shelter-hero](http://www.gorooft.com/shelter-hero). Please include a brief description of why you believe that the nominated veteran deserves a new roof for his or her home.
2. **Entry period.** The Contest opens at 8:00 a.m. on Friday, November 11, 2016 and closes at 5:00 p.m. on Thursday, December 22, 2016.
3. **Eligibility.** This contest is open only to active or retired members of the United States Armed Forces who have not been dishonorably discharged. One registration per eligible household. Property submitted at time of entry must be a single-family detached residential property. Property submitted must be the owner's primary residence. Any submission deemed to be inappropriate, offensive or illegal will be denied at the sole discretion of Advantage Roofing. You must be 18 years of age and a legal resident of the United States to be eligible to win this prize. Employees of Advantage Roofing and their immediate families are not eligible to win. You must be the property owner of the property submitted.
4. **Geographic area.** Submissions will only be allowed for properties located in the following counties:
  - a. **Indiana:** Dearborn, Switzerland and Ohio counties.
  - b. **Kentucky:** Boone, Kenton and Campbell counties.
  - c. **Ohio:** Hamilton, Butler, Warren and Clermont counties.
5. **Determination of winner.** The determination of the Winner is in the sole discretion of Advantage Roofing. Upon selection, the winner will be asked to provide adequate proof of active or retired military status and proof of need for new roof. Final determination of eligibility shall remain in the sole discretion of Advantage Roofing.
6. **Grand Prize.** The Grand Prize is free installation of a roof at an eligible residence. The following limitations on the roof apply:
  - a. Size limit: 25 SQ. maximum. Additional charges apply above 25 SQ.
  - b. Wood limit: 100 sf maximum wood replacement included in Grand Prize. Additional charges will apply above 100sf.
  - c. Type of shingle: CertainTeed Landmark.
  - d. Warranty: 50 year manufacturer's warranty and 50 year Advantage Better than Lifetime Warranty.
